

The Washington-Kosciusko Global Porum

Bringing the World to Winona!

Communities across the country are increasingly diverse. The challenges facing communities are complex; our global interdependence is more apparent than ever before. For society to collectively confront global issues, all sectors –corporate, nonprofit and government – require globally literate and culturally competent employees, citizens, and leaders.

Last Fall, second grade teacher Luke Merchlewitz submitted a Dare to Dream Grant to the Foundation for Winona Area Public Schools with the help of WSHS Senior Calvin Dretzke. Their dream was thinking globally through the utilization of a common theme, the importance of water. Multi-age W-K students engaged in a Global Forum by learning about the world and its people, as well as, conducted action-based service learning projects that focused on water in our world.

Mr. Merchlewitz found research that showed students who learn about global problems are more than twice as likely to see the point of personally undertaking social action. Global learning encourages awareness and critical thought about issues such as poverty, climate change, politics, international trade, and different religions and cultures. Globally-minded students are more likely to exhibit tolerance and acceptance of religious, cultural, and ethnic diversity. The ongoing Global Forum was conducted, along with the assistance and cooperation of numerous institutions, such as WSU, WAPS, the City of Winona, the International Institute of Minnesota, and WaterProject.org.

Luke held a reception at W-K and invited community members, City of Winona and Winona Area Public School staff, University Leaders and parents. The event highlighted independent projects that each student worked on, as well as, a short documentary following the Global Forum from conception until its project finish. The uplifting and interesting video can be found on You Tube under the WK Global Forum. When interviewed, a 4th grade student who worked on the Global Forum project summed up the feeling of the group perfectly, stating "Now I feel I have the power to change the world".

The Foundation's Board of Directors supported the iCan Bike After School Program with a grant. Melinda Reinhardy submitted a request to the Foundation to support a program that teaches WAPS students with special needs how to ride a conventional two-wheel bicycle and teach biking skills so they can become lifelong, independent riders. This program is also designed to help promote self-esteem and confidence, while improving quality of life with physical activity. It also provides a service learning opportunity for WSHS students as they learn disability awareness training. The goal is for peer spotters to become educated in regards to diversity and open their minds to acceptance and inclusion. Elated faces and squeals filled the gym and outdoors as the students mastered the skill of riding a two wheeler. Spotters were often "left in the dust" as the bikers independently whizzed by.
